


K1R is Here!

Updates from the St. Lawrence Seaway

John-KC2MBB lives along the seaway in Massena, New York. He frequently braves the sub-zero weather to park on the upper observation deck parking lot, reporting to us on the work going in at the Eisenhower locks. This is an important shipping bypass to the American-Canadian power dam at Massena.



When winter strikes all shipping ceases on the seaway, thus allowing the Army Corps of Engineers and repair contractors to drain the lock, making much needed modifications and repairs before the spring shipping season begins. John was there around the 16th of March when work was completed and the flooding of the locks began. With this finished the monster grain, ore and other large vessels will once again transverse the St. Lawrence. Many Thanks John!

Wooden Satellites ?

While watching the return of Crew-9 from the space station on March 18, 2025, a reporter mentioned that one of the experiwas to launch wooden satellites.

Five CubeSats were deployed into Earth's orbit from the International Space Station. Among them was LignoSat, a wooden satellite from JAXA (Japanese Aerospace Exploration Agency) that investigates the use of wood in space. Find-

ings could offer a more sustainable alternative to conventional satellites.

A previous experiment aboard station exposed three species of



wood to the space environment to help researchers determine the best option for LignoSat. The final design used 10 cm long honoki magnolia wood panels assembled with a Japanese wood-joinery method. Researchers will use sensors to evaluate strain on the wood and measure it's responses to temperature and radiation in space. Geomagnetic levels will also be monitored to determine whether the geomagnetic field can penetrate the body of the wooden satellite and interfere with its technological capabilities. Investigating uses for wood in space could lead to innovative solutions in the future. For further reading:

FCC Initiates Broad Inquiry on Rules to Delete or Amend

From ARRL...

In a Public Notice titled "In Re: Delete, Delete, ments done while astronauts were in orbit Delete," issued on March 12, 2025, the FCC is soliciting public input on any FCC rules in any service that members of the public believe should be deleted or modified "for the purpose of alleviating unnecessary regulatory burdens."

> This is the latest in a series of similar proceedings going back to 1996, when the Communications Act was amended to require the FCC to periodically review its rules.

> ARRL, through its Executive Committee and FCC Counsel, is conducting a review of the provisions in Part 97 and other related rules that apply to radio amateurs. ARRL is also soliciting feedback from its members. Rules identified as outmoded, obsolete, or that for other reasons should be repealed or modified, will be included in ARRL's filing to be submitted no later than the FCC deadline of April 11, 2025. The deadline for filing reply comments is April 28, 2025.

It is expected that the Commission will incorporate suggestions that it decides worthy of its consideration in a future Notice of Proposed Rulemaking (NPRM) that could be issued later this year. There will then be an opportunity for public comment on the specific rules that the Commission proposes for deletion or modification. 
